1. Call to order/Roll Call:

10. OLD BUSINESS:

A. DISCUSSION AND ACTION - Ordinance 2021-12 (AN ORDINANCE TO AMEND THE CODE OF THE VILLAGE OF HOBART, SPECIFICALLY SECTION 12 (NUMBER OF ANIMALS LIMITED) OF CHAPTER 102 (ANIMALS) OF ARTICLE III (LICENSING AND REGULATION OF ANIMALS)):

The purpose of this ordinance is to limit the number of dogs on properties of 2 ½ acres or less to two and to five on properties over 2 ½ acres in size. This is the second reading for this ordinance Motion by Rich Heidel, second by Ed Kazik, to approve Ordinance 2021-12 (AN ORDINANCE TO AMEND THE CODE OF THE VILLAGE OF HOBART, SPECIFICALLY SECTION 12 (NUMBER OF ANIMALS LIMITED) OF CHAPTER 102 (ANIMALS) OF ARTICLE III (LICENSING AND REGULATION OF ANIMALS)). The motion passed unanimously.

A. DISCUSSION AND ACTION – Request to Change Zip Codes:

Due to development and redirecting of traffic in the near future and the new Highway 29-County VV Interchange, a number of zip code changes in the northern part of the Village is being requested. Motion by Rich Heidel, second by Ed Kazik, to approve the assignment of the Development Agreement between Bayland Buildings, Inc., and the Village of Hobart to the North Hobart Business Park, LLC and the Village of Hobart. The motion passed unanimously.
